Student Spotlight: Introducing Sam Boswell III

Sam Boswell III decided to attend SHSU once he visited the campus. He had visited many campuses prior to coming to SHSU, however during his guided tour of SHSU, he fell in love with the campus and small size of the university. Sam entered SHSU as a freshman in the fall of 2014. With an accounting major and a minor in management, Sam is on track to complete his degree in December 2018.

Sam grew up in and around his family's Ford dealership in San Benito, Tx, which is in the Rio Grand, Valley. This past summer, Sam gained an internship with Ford Credit in Colorado Springs, CO. Over 500 students applied for the internship, but only 12 students were selected! Of the 12 who were selected, only two were not specifically recruited (targeted) by Ford Credit. Sam simply applied online for the internship and advanced (successfully) through the process.

Having insight and experience with Ford allowed Sam to understand the inner workings of a dealership and what takes place on the other side, to actually experience what Ford Credit does. He benefitted from having a greater understanding of Ford and Ford Credit as well having greater insight on Ford's different model of cars sold and how the process of buying a car works. He was also able to provide personal insight regarding what selling a car was like and what complications there might be along the way. The internship made Sam more loyal to the company as Ford has been a huge part of his life due to the family dealership. Sam wanted to work for Ford, and it showed via his passion and enthusiasm about the work he completed during the internship.

At the conclusion of Sam's internship, he was offered a position in the Ford Credit Leadership Development Program. The program is basically a fast-track path to get younger people into management positions since many of the current managers are already eligible to retire. He will start in the business center and rotate through the various positions.

Once he "graduates" from the program, he will be able to go to other eligible positions, gain additional experience,

and continue moving up within Ford Credit or possibly switch to the Ford Motor Company side. The Leadership Development Program is designed to last about two and a half years.

As Sam approaches the end of his time at SHSU, he has taken a little time to reflect on his experiences. He characterizes his time at SHSU as being "very interesting." He has learned far more than he thought he would. In addition, he is amazed that he is graduating with a degree in accounting! He did not think getting a degree in accounting would be something he could accomplish when he entered as a freshman. There have been plenty of frustrating times, especially as he has studied accounting. In fact, he changed his major to accounting at the end of his junior year, which is what most would consider a very late change. However, looking back now, Sam sees that changing his major was definitely worth all the frustrating times.

The advice Sam would give to his younger self would be not to slack off. Work as hard as you can and get your GPA as high as you can while the classes are easier. He would also say do not be afraid to ask for help and or reach out when you feel you do not understand something. And it's also alright if you feel out of place in college initially because it could be a huge change from where you came from and eventually you will begin to adapt into the college environment. He would also say to continually look for ways to improve yourself and to constantly keep looking for ways to learn new things. Even if the core class you are taking are not in your major, the classes may still be useful later in life.

My decision to become a business professor was, in part, a reflection of the environment that I grew up in. Growing up, I remember listening to the stories shared with me by grandparents and uncles about their businesses as well as the struggles and triumphs that they faced running their businesses. When I went to college, I was drawn toward business courses, so much so that I eventually decided to major in Finance. It was during my time at Southern Utah University (SUU) that I experienced firsthand the profound influence that caring professors can have as they mentor students. This, coupled with the rewarding life I observed my father create as a college professor, inspired me to pursue a Ph.D. After graduating from SUU with my undergraduate degree. I took a job as an accountant and simultaneously began the process of applying to graduate schools. I chose to pursue a Ph.D. in the field of

Strategic Management because I wanted to better understand why some businesses succeed while others fail. Eventually, I was accepted into the Ph.D. of Management program at Texas A&M University and after five long hard years, I graduated.

Receiving tenure represents the end of a journey which has taught me to be open to new and unexpected life experiences. Just as entrepreneurs and business leaders must pivot and update their strategies in the face of changing business conditions, individuals also benefit from being open to the various experiences life has to offer them. Such life experiences may not conform to what one expects in their youth.

A key to success then becomes to learn from new and unexpected life experiences and to be willing to take advantage of the opportunities that they present – to pivot and update your own strategies when

conditions in your life change. Early in my career, I could never have imagined the people I would meet, the places I would visit, the things I would research, and the things I would learn about the world we live in. Receiving tenure also represents the beginning of the next stage in my career journey, one which will likely hold new and unexpected experiences. As I approach these experiences, I hope to validate the confidence that SHSU students, colleagues, and administrators have expressed on my behalf by granting me tenure.

My most memorable experience at SHSU took place when I interviewed for a job here. The collegiality of the students, faculty, and administrators stood out to me during the interview process and made SHSU feel like home. Since joining SHSU, this perception has been reinforced again and again. It is good to be a part of the Bearkat family.
