## **10 21 00 COMPARTMENTS AND CUBICLES**

- 10 21 13 Toilet Compartments
  - A. Utilize vandal resistant Phenolic Partitions
  - 1. Use Floor & Wall hung toilet partitions.
    - A. Where additional supports are required, such as at "L" shaped configurations or where one side is open, use posts to accommodate structural requirements. It is preferred the posts are as small as possible.
  - 2. Use wall-mounted vanity panels at urinals.

# **10 26 00 WALL AND DOOR PROTECTION**

10 26 13 Corner Guards

A. Utilize acrylic style 3" corner guard with hidden metal retainers and coordinated/matching colors.

- 1. Provide in all public spaces, service areas and at specialty finishes.
- 2. Protect outside corners of gypsum board partitions in public corridors to minimum 36" height.
- 3. Prefer wall protection at chair rail height for public areas with moveable seating.

- A. All Accessories shall be Stainless Steel
- B. Provide and install toilet room accessories as follows:

  - 3. Towel Dispenser Kimberly-Clark Professional SKU 31501
