## **Special Guests**

#### **Senate Committee Reports**

#### **Academic Affairs Committee**

Senator Hatton (Chair of AA Committee) shared that the AA committee continues to work on APS 900823 – *Academic Grievance Procedures for Students*, including feedback received from Dr. Gaillard.

## **Committee on Committees & Surveys**

Senator Lantz (member of the Committee on Committees and Surveys) presented the review of APS 930129 *Graduate Degree Enrollment and Completion Requirements* on behalf of the CC committee. The members of the CC are satisfied with the current version, in particular, the inclusion of enough flexibility to allow exceptions. Senator Hatton moved to accept the recommendation of the CC committee and the motion was passed.

# **Faculty Affairs Committee**

Senator Adu-Prah (Chair of the FA Committee) presented the review of APS 860904 *Academic Credit for Experiential Learning* on behalf of the FA committee. The FA committee had no further comments, however, during discussion, several senators agreed that further clarification on point 2.05 is needed to fully understand the process described in this policy.

## **University Affairs Committee**

Senator Wang (Chair of the UA Committee) presented the review of APS 890303 *Employment of Graduate Assistants*. The UA committee presented several concerns regarding the language certification process of graduate assistant as it is currently described in the policy. The UA committee will continue to work on this policy.

# **Shared Governance Committee**

Senator Sherrill presented an update of the work done by SG committee. They will provide a proposal next FS meeting.

## **Unfinished Business**

APS 860211 *Instructional Materials Acquisition Policy*. Senator Hay (Chair) presented the recommendation that the term "pricing structure" be replaced with "royalty structure" to better reflect how decisions regarding fairness of pricing are made. Senator Calloway moved to accept the recommendation and the motion was passed.

## **New Business**

Senators Doleshal, Hay, Price, and Rapp, presented the *Senate Resolution on Proposed Policies on Faculty Performance, Tenure and Promotion, Post-tenure Review, and Merit.* Through this resolution, it is requested that the Provost begins the revision process of the following policies anew (when revisions are necessary),

- APS 900417 Faculty Reappointment, Tenure, and Promotion
- APS 800722 Merit Advances in Salary
- APS 820317 The Faculty Evaluation System
- APS 980204 Performance Evaluation of Tenured Faculty

Moreover, it is also proposed that, if revisions are needed, these are done through the appointment of a working group, consisting of an appropriate mix of faculty and administrators. The aim is that faculty input is included in this process from the beginning. Senator Radoias moved to accept the resolution and the motion was passed.

## **Strategic Plan**

Senator Hatton, one of the Faculty Senate representatives in the Strategic Plan Committee, presented a series of questions regarding the Strategic Plan and gather feedback from Faculty Senate.
