#### **Chair Report:**

Chair Philip Morris reported on items discussed at recent APC meetings and other issues of interest.

- The APC reviewed and updated Academic Policy Statement 810806 Student Educational Records and Academic Policy Statement 990407 Student Resignations.
- The APC is in the process of reviewing and updating Academic Policy Statement 910116 – Off Campus Instruction and Academic Policy Statement 940202 – Payments to University Employees for Services.
- The APC has asked the Faculty Senate to review Academic Policy Statement 860904 Academic Credit for Work. (The Academic Affairs Committee was tasked with reviewing the policy and reporting back to the Senate.)
- The APC approved CAD's recommendation that all students complete 2 composition courses, 1 lab science, and 1 math course BEFORE being allowed to enroll in ANY upper-level courses.
- To speed-up delivery of the IDEA forms, the forms will no longer be delivered to the Dean's office and then distributed to the departments. Instead, IDEA forms will go directly to the departments from IR.
