### **Called to Order**

### **Approval of Minutes**

The minutes report for the November 3, 2023, meeting was approved.

### **Senate Committee Reports**

### **Academic Affairs Committee**

The Academic Affairs committee reported on its review of *APS 840606 Library Use*, and recommended that the policy be approved with several editorial suggestions to sections 2.2 and 4.5. The AA committee also raised questions for clarification on items related to sections 6.8, 6.10, and 8.2. Faculty Senate voted unanimously to approve the policy with the provided comments.

### **Committee on Committees & Surveys**

The Committee on Committees & Surveys reported on its review of *APS 890303* - *Employment of Graduate Assistants*, noting concerns related to definition consistency in sections 1.1 and 2.1, and various additional concerns related to sections 2.1, 4.02, and 6.01. Faculty Senate also discussed concerns related to section 7 regarding the referenced policy, *APS 871214, English Language Proficiency for Instructional Personnel*; and agreed that the last sentence within section 7 be struck from the policy. Faculty Senate voted unanimously to approve the policy with the suggested revisions.

### **Faculty Affairs Committee**

The Faculty Affairs committee reported on its review of APS 871214 - English Language Proficiency for Instructional Personnel, noting several major concerns pertaining to

anticipated procedural complications; incongruencies between the policy and its referenced processing document; and limited details addressing warranted use of the referenced processing document. The FA committee recommended the policy be rejected and sent back to address these concerns. Faculty Senate voted unanimously to reject the policy.

## **University Affairs Committee**

The University Affairs committee reported on its review of *APS* 950531 – Undergraduate Degree and Certificate Requirements and Specifications, noting that while the committee generally agrees with the overall policy and its revisions, it has a major concern with the policy's complete elimination of a credit expiration period. Following senate discussion, the UA committee recommended rejecting the policy and sending it back to allow for further deliberation on this item. Faculty Senate voted unanimously to reject the policy.
